SELECTION CRITERIA OUTLINED ON USS WEB SITE & IN ICE CHIPS #86 & #87

Eligibility: Skaters must have reached the age of 12 but not the age of 19 as of July 1, 2005. **The 1000m time standards are Men: 1:44.00, Ladies: 1:57.00** (Eligibility Form Must Accompany Entry Form) which must be established between 12/18/04 and 11/02/05. This can be met in a short track 9 lap time trial or 1000m mass start, in a USS sanctioned competition or a sanctioned short track competition by the ISU or an ISU member country. All qualified skaters are eligible to skate the time trial. Remaining events are limited to the top 16 men and top 16 ladies (note: if there are 17 or more entries, male or female, a second group will skate, up to a maximum of 16 skaters. An additional 3rd group will also be eligible to skate).

NOTE: Participants must have reached the age of 14 before July 1, 2005 in order to be eligible to compete in the 2006 World Junior Championships; anyone under this age will not be considered part of the Junior World Team and will not receive benefits that may be available to the Junior World Team.

Best 1000m time from December 18, 2004 through November 2, 2005, (for seeding): _____

ENTRIES (with fee & other required paperwork) MUST BE RECEIVED BY OCTOBER 26, 2005.

LATE ENTRY: \$90 fee (\$40 + late fee of \$50), entry form and other required paperwork must be received by 6PM EDT on November 2, 2005 to be eligible to compete.
