The race schedule will be per ISU age requirements and may be changed or combined at the direction of the sponsors or officials. Equipment Required: Long sleeve jersey, gloves, neck protector, shin guards and a hard shell helmet.

Directions to the Midland Civic Arena: **From Bay City/Detroit (East/South)** - From US 10, take first Midland exit (Bay City Road), turn left onto Bay City Road, the Civic Arena is approximately 1 mile West from expressway.

From Mt. Pleasant (West) - Take M20 into Midland, turn right on Business 10 (Buttles St.), stay in right lane for approximately 3 miles. Just past Dow Credit Union turn right onto James Savage Road exit, go through light. Turn right onto Saginaw Road, turn left at second light onto Bay City Road. Arena is approximately 3 miles.

From Clare (North) - From US 10, take last Midland exit (Bay City Road), turn right onto Bay City Road, the Civic Arena is approximately 1 mile West from expressway.
